Site description

- Situated off The Spinnaker
- Detached dwelling

Officer's report

The tree is a mature lapsed pollard specimen within the front garden of the dwelling. The tree is clearly visible from public vantage points and forms a prominent specimen within the area. The tree contributes a high level of visual amenity value and adds a leafy character, juxtaposing the built urban environment in which it is situated.

A number of features were noted during the site visit that indicated stress, this included multiple species of gall, powdery mildew and browning and wilting of leaves. New growth noted to the apical aspects of the crown were sparse and stunted.

The tree has recently been reduced by ways of 2.5 m crown reduction and removal of weak, dead and crossing branches, with works last approved in 2022 under application 22/05144/TPO. The tree appears to continue to recover from the previous works and requires further time to recuperate energy levels. Prior to this an application for a 1.5 m crown reduction and 10% thin was approved in 2016 (reference 16/05244/TPO).

The application seeks to reduce the crown 3 m, this would reduce the tree past the previously established pruning framework and create large wounding. The large wounding would increase the likelihood of the ingress of pests and pathogens leaving the tree vulnerable and susceptible especially given the tree has depleted energy levels as it continues to recover from the previous pruning operation. The reduction

proposed would also remove a large amount of photosynthetic material, which would stress the tree (which it is already displaying signs of). The works would not only harm the tree but would also impact the amenity value the tree offers to the area.

The application also includes the cutting of weak, dead and crossing branches. This generally forms good arboricultural practice and was recently allowed under 22/05144/TPO as such it is not anticipated there would be many weak or crossing branches and the removal of dead branches from a living tree forms an exception and does not need the permission of the Council. For clarity a split decision is recommended to allow the cutting of the weak, dead and crossing branches with a 3 m crown reduction recommended for refusal

It was noted on site that there was sufficient clearance between the canopy and the dwelling so as to not cause abrasions. The reasons provided with regards to light would also not comply with GT9 of the Council's Tree Management Policy dated October 2021, which states that the Council will normally refuse unnecessary works merely proposed, including: loss of sunlight. Squirrels had also been noted as a reason for works however this would not justify the excessive pruning works proposed to the entire crown and other mitigatory works should be explored to allow the tree time to recover. It would be expected that oak trees are cut on a cycle of approximately 6 - 7 years, to allow recuperation and recovery.

The Town Council had also expressed a concern for the application and believe that the 3 m crown reduction is excessive.

For the reasons given above and having regard to all other relevant matters, the cutting of weak, dead and crossing branches is acceptable, however the 3 m crown reduction of T11 is excessive and should be refused.

Site description

- Situated off Reynolds Gate

Officer's report

The tree is a mature and impressive specimen that can be seen from Reynolds gate with almost 360° views from public vantage points (with cycle path (73)) that lines the southern boundary to the rear of the dwelling. The tree provides the urban area a high level of visual amenity value and softening the surrounding built form.

The tree is a mature specimen that displays signs good physiological condition. The canopy is dense and vigorous with epicormic growth noted on the primary limbs throughout the canopy. There were signs of what appeared to be oak marble gall wasp (*Andricus kollari*), within galls would be larvae that feed on the host however, they however cause minimal damage and would not be anticipated to cause unacceptable harm to the tree.

The tree has been managed previously by ways of 1.5 - 2.5 m crown reduction at 3 - 6 year intervals last approved in 2022. The application originally sought a 2.5 m crown reduction and the removal of deadwood > 50 mm. To be clear the removal of deadwood forms an exception of works that require notification of consent and as such can be undertaken. The tree, when compared to the application images from 2022, had not produced as much new growth and when viewed on site a 2.5 m reduction would have reduced the tree

past previous pruning points. It was recommended, in line with 2022, 2015 and 2011 applications that the works did not exceed 2 m (1.5 - 2 m) which was agreed.

The tree has begun to encroach over the southwestern corner of the extension with the outer growth of the northeastern aspect of the crown beginning to abrade the guttering of the property.

The works proposed would reduce the tree back to its previously established pruning framework. The works will mitigate abrasions against the dwelling and would improve the relationship between the tree and the built surroundings.

The Parish Council had also commented on the original proposal of 2.5 m crown reduction noting they would prefer to see a 2 m reduction. The Council also agreed with this and had agreed with the agent a lesser reduction of 1.5 - 2 m back to previous pruning points.

For the reasons given above and having regard to all other relevant matters, the proposed work is acceptable.

Condition 1

The tree surgery hereby permitted shall be carried out within two years from the date of this permission. Reason: As required under the Town and Country Planning Regulations 2012.

Condition 2

The tree surgery shall be undertaken in accordance with British Standard 3998:2010 Tree Work - Recommendations.

Reason: To promote good arboricultural practice and safeguard the existing trees.

Notes to Applicant

- 1 WARNING: You run the risk of being prosecuted if you do not adhere to the approved specification when carrying out work on the protected trees. The person carrying out the approved work must have a copy of the decision notice with them.
- Tree surgery is a skilled operation and it is recommended that you consider seeking the services of a competent tree surgeon before carrying out the works. The Arboricultural Association holds a directory of competent tree surgeons which is available on their website: https://www.trees.org.uk
- Before operations, the person undertaking the work to the tree(s) must ensure that it does not contain any bat roosts or nesting birds. The bats can be found in the tree cavities and cracks within the dense ivy or epicormic growth. This is because it is an offence under the Wildlife and

Countryside Act 1981; the Habitat Regulations 2017 and the Countryside Rights of Way Act 2000 (CROW) to intentionally or recklessly kill, damage or disturb bats and their roosts, or intentionally take, damage or destroy the eggs or nest of any wild bird while in use or being built. 

1. New Bridges both completed

We have notified Essex Highways of the completion of the works.





2. Fence and posts removed

Fencing was removed other than a small section of posts which had grown into the bushes and would require the bushes to be damaged in order to remove them.

3. Tree works carried out

Tree works have been carried out to the Fen in order to remove any dead trees by the entrance area and cutting back of one of the big Oaks.

4. Charles III footpath

Essex Highways are due to start works on the footpath 23 to improve the surface. New signs are likely to be installed next spring.

5. Annual Hay Cut

The Annual hay cut has been completed over the Fen on 22/9/2025.

Response to inbound media enquiry re South Woodham Ferrers

A spokesperson for McCarthy Stone said:

"Regrettably we have decided not to continue with consideration of a new retirement community at Baron Road in South Woodham Ferrers. A combination of factors in an increasingly challenging housing market mean it is no longer financially viable for us to proceed with taking this scheme to the planning application stage.

Nonetheless we continue to look for suitable sites in the area and hope to come forward with a proposal at an alternative location in the future.

In the meantime, we would like to thank all those locally who engaged with us during the public consultation in the summer."
