PR258 Public Questions

A representative from Swallows Gymnastics explained the request to the Town Council for a grant for new equipment. He stated no fund raising has been possible over the last couple of years due to Covid.

A representative for Eyotts Sailing Club gave Committee an explanation for the request of a Town Council Grant towards flood defence barriers and agreed to send the Town Clerk an electronic pdf document detailing information and costings for circulation to members.

A representative for the Railway Station Adopters explained the request for a Grant included the planting of a tree and a plaque for the Queens Jubilee

Councillor Massey confirmed that the Grant application form request was for \pounds 500.00 and the Town Council would not be able to award a Grant for work already completed so the value to be considered at the meeting would be the amount stated on the Grant application.

A representative from Swift Singers explained they have attracted some new members but they have been low on income the past two years. The last grant requested was for staging in 2016. They are requesting money for uniform and music.

Committee considered the request from the Leisure Committee to allow hall hire in the Main Hall to facilitate a weekly toddler group. £10k grant received from Essex County Councillor Massey towards equipment. Councillor Humphrey updated the response on social media has been phenomenal. Councillor Thompson also mentioned that Health Visitors would be interested in attending sessions for baby weigh in. Loss in revenue at the hall would be subsidised by a small weekly charge. This new group would be treated as a project for year one supported by the Town Council and reviewed after a one- year period.
