C456 Chelmsford City Council / Essex County Council

- Councillor John updated the Council on the following: Chelmsford City Council Chelmsford City Council meeting Regulatory and Advice Committee meeting. Incidents are taken very seriously and taxi drivers licenses are reviewed and the magistrates courts makes a final decision.
- Councillor Massey updated the Council on the following: Essex County Council

Essex County Council has, this week, introduced a trial booking system at all its household waste recycling centres, this follows a trial introduced at Rayleigh recycling centre in May 2022.

Rayleigh Recycling Centre was chosen as the initial test site as the size and location of the site was causing significant queues and congestion within the area. Since the booking system was introduced, we have seen a significant reduction of queues and have received an overwhelming amount of positive feedback from residents who participated in a survey in Autumn 2022.

Following feedback received at Rayleigh we have introduced the capability to book same day slots, and if the trial is successful then its likely that an App will be produced.

Booking systems have been operating successfully in many other counties including Hampshire, Kent, Suffolk and West Sussex.

Across the 21 recycling centres operated by Essex County Council, we will offer nearly 40,000 visits per week in summer, and nearly 35,000 visits each week in winter.

There is no restriction on the number of bookings you can make as long as the waste you are disposing of is household waste.

Since launching both the Van and Rayleigh booking systems, we have received no reports of increased fly-tipping incidents in the county. Last year, DEFRA carried out research on the matter, and found no evidence of a correlation between introducing bookings at recycling centres and an increase in fly-tipping, in some areas it actually decreased.

The trial will be fully evaluated in Autumn 2023. If the evaluation suggests that the introduction of a permanent booking system is under positive consideration, the council will launch a consultation on the preferred option and any alternative options. Any permanent proposals following the outcome of the evaluation and consultation will be subject to a separate decision.

The project will be discussed at the County Council's Place Services and Economic Growth Policy and Scrutiny Committee later this week and we expect to further engage with Scrutiny later this year.
