To consider report(s) to Council from City Councillor/County Councillor concerning matters of interest to South Woodham Ferrers:

Councillor Eley updated the Council in the absence of Councillor Massey on the following:

Essex County Council

- The County Council Cabinet today (Tuesday 16th) discussed and agreed to increase the County Council's proportion of the domestic household precept by 2.99%, plus the 2% allowed by Government for Health and Social care. This will be formally approved at full council next month.
- The ten trees allocated from the Essex Forest Initiative were delivered to the Town Council on December 15th.

- Several of the potholes identified in the tranche submitted last October
 - at Ormesby Chine, Coberg Place and Ferrers Road adjacent to the
 Hullbridge Road crossing have been scheduled for repair.
 A new strategy for road and footpath repairs is being considered by
 Essex Highways and Councillors await a formal announcement.
- Following last month's collision between a pedestrian and van, the zebra crossing on Inchbonnie Road adjacent to Leighlands Road has been reported to the Essex Road Safety Partnership and the Local Highways Panel, with a view to upgrading lighting in the area and installing brighter Belisha beacons.
- Councillor Massey also submitted a request to the Local Highways Panel, at the request of Woodville School, for a pedestrian barrier on Brent Avenue, where a parent was struck by a car.
- Clements Green Lane is scheduled for resurfacing week commencing February 1st, weather permitting.
