Policy DM29 of the Chelmsford Local Plan states that planning permission will be granted for development proposals provided that the development safeguards the living environment of the occupiers of any nearby residential property by ensuring that the development is not overbearing and does not result in unacceptable overlooking or overshadowing. This is not the case here; the Juliet Balcony will overlook several properties and reduce any current expected privacy and would cause overshadowing by the design to other buildings at times of the day.

This addition to the roof goes above and beyond anything which is currently installed on any roof in the immediate area, and we believe DM29 states about "overbearing development", which would be the case. This room may also lead to additional noise to escape from the property.

There are also concerns over the effect on party walls and foundations for the property adjoining the development.
