Councillor O Brien – No Update **Essex County Council**Council Massey Reported –

### **Devolution and Local Government Reform**

As I reported at the last meeting of the Town Council, Essex County Council submitted the letter to HM Government regarding Devolution and Local Government Reform on behalf of the various district, borough, city and unitary authorities. This was accepted by HM Government and Essex is confirmed to be within the first tranche of Counties to undergo reorganisation.

This means that the County Council elections for May this year have been suspended and that an election for the new 'Mayor of Essex' is expected to take place on May 7th 2026.

Today (March 18th) Essex County Council's cabinet agreed to submit its interim proposals to the Government, these have been agreed by all the District and Unitary Councils.

Various options for the structure of local authorities going forward are being discussed, suggesting 3,4 or 5 unitary authorities. The Government's guidance is that authorities should represent around 500,000 residents; and Essex currently has around 1.9 million residents.

The final decision will be made by the Secretary of State for Levelling Up, Housing and Communities (formerly the Ministry of Housing, Communities and Local Government) following a further submission in in September.

The timeline for Devolution and LGR is:

**21st March 2025**: Submission of Interim Proposals Plan to the Government

**26th September 2025**: Submission of the developed Unitary Authorities and implementation plans to Government

**February 2026**: Delivery of implementation plan and key stages/milestones

May 2026: Mayoral Elections

May 2027: Shadow Authority Elections

**April 2028**: Vesting Day (District and County Council cease to exist)

**Highways** 

The majority of local highways repairs in recent months have focused on footpath repairs, several of which have caused injuries to residents.

I'm pleased to be able to report that, after several years of badgering, repairs will be affected to the foot path/cycle path between Chetwood and Chamberlain's Ride during the month of April.

Similarly - after pressing for more than five years - the proposal to upgrade the 'Asda' zebra crossing to a light-controlled crossing has finally reached the design phase. The upgrade has been estimated as costing around £180k which is too high for the Chelmsford Local Highways Panel - which has an annual budget of £250k. It will therefore be considered by ECC's new "Chairmen's Panel".

As always, I invite members of this council to notify me of any highway or footpath issues that require urgent attention, including the appropriate Essex Highways Tracking reference.
