# PR96 Champions Manor Hall Current Situation

The building currently remains closed to members of the public with staff working on site on a rotation basis.

#### Income

It was noted that based on regular bookings and 2 parties a week the monthly loss of hall/room hire income is approximately £7,500 (based on 2020 prices) however during August the hall hire income is invariably considerably reduced due to pausing of clubs.

It was noted that Councillor Roberts assisted in the acquisition of a Chelmsford Council Hospitality/Leisure Grant of £25,000 which was received on  $26^{th}$  May.

### **Expenditure**

It was noted that:

- 2 members of staff are currently furloughed
- Servicing: fire/lift/security cameras were carried out as normal
- · Regular building checks have been carried out.
- Bins and sanitary services have been reduced.
- Cleaning is currently not being carried out.
- Three sanitisation stations have been purchased but as yet not installed.
- Appropriate signage and markings will be purchased once further guidance is provided.

At this time there is very little guidance as to the measures that will be needed to be in place when Champions Manor Hall opens to the public. It is anticipated that further guidance will be issued on 4<sup>th</sup> July which will be considered at our next meeting.
